### Preferred Material

- InDesign, Quark, Illustrator (please convert all fonts to outline), or Photoshop (If layers are not needed for final artwork, please flatten all layers). All images in the ad should be 300 dpi or higher, and all fonts (screen and printer) must be supplied.
- We cannot accept Windows Post Script fonts (.pfb/.pfm). Spot colors, unless arranged in advance with your sales representative, will automatically be converted to CMYK. Please be aware that while we make every effort to match color, there may be a color shift due to the process of converting spot colors to CMYK. Crop and bleed marks should appear outside of the bleed and trim of the ad. When creating the PDF, crop and bleed marks should be turned on, with the Offset set to at least .125".
- Ads can also be submitted via email and if color is critical please supply a proof. Please include the name, phone number, and e-mail address of the designer in the event that we would need to contact them about the ad.
