We tore out three-quarters of our law library a few months ago. Rows and rows of once-precious hardbound case books and collections of treatises gave way to technology and the need for more office space.

The law library once represented the pride of a law office. Clients were regularly escorted through the halls and past these rows of books with remarks such as, "See, we are really smart and scholarly attorneys, look at all our books."

Building a law library with the necessary collection of books was an expensive task. Either you had the books in your library, borrowed them from another practitioner or ran over to the Ventura County Law Library.

In the 1980's, my firm came across an ad in the *LA Daily Journal* for the sale of the first series of the *California Reports* (the first volume being 1850-51) and first series *California Appellate Reports*. The Los Angeles attorney was closing up shop and going fishing. Back then these volumes were hard to come by and expensive. My legal skills were of such nominal value that the partners decided I should forget about billing for the afternoon and drive to Los Angeles to retrieve all of these volumes. So I headed to LA in my two-door 1975 Chevy Malibu.

The office of the soon to be retired LA attorney was right out of the Perry Mason days. His empty desk and marked-up desk pad showed that his career had come to an end. I transported load after load of books down the freight elevator until my Chevy Malibu was full. There was barely room to see out the back window. Upon my return to our Ventura office I was greeted like a returning hero as we unloaded the legal treasure and filled the shelves. These books were dusty leather-bound volumes. Now we find little need to open the covers.

There is something scholarly in turning the pages of these old volumes and having the books lay open all over your office. It's just not the same clicking the screen and pulling up the case on the computer. I swear I can find what I need faster in looking at the bound volumes of *Miller and Starr* than searching the computer.

I cannot say I miss "shepardizing" cases the old way by looking at the collection of hardbound and soft-bound Shepard monthly and weekly updates.

Apparently you cannot sell or even give away many of these hard-bound legal books. I'm starting to see these law books pop up more frequently as background. They seem to be stuffed on shelves on many movies and television shows.

The electronic world has also affected law school libraries. Herb Cihak, Associate Dean of the Pepperdine Law School Library, tells me that the school's law library is now divided approximately 50/50 between hard copy and electronic subscriptions. Apparently current students don't like to use paper material and instead turn immediately to electronic works. Today more than 90 percent of the students have laptops during lectures. Dean Cihak noted that several professors were beginning to use live lecture response questions to assess student learning. Students answer multiple choice questions during lectures to gauge "if they are getting it." So much for sleeping in the back row during the lecture on the rule against perpetuities.

There appears to be little chance of holding back the rushing tide. In July, 2010 *Amazon. com* announced that for the prior three months sales of books on its Kindle e-reader outnumbered sales of hardcover books. Some think that within the next decade fewer than 25 percent of books sold will be in print version.

As for me, I'll stick with the stack of four or five half read books at my bedside. I swear I'll get to them, right after this next *Seinfeld* re-run, which I've seen 25 times.



California's Expedited Civil Jury Trials

Are you familiar with the procedure for one day civil jury trials? The purpose of the new law, passed in January with the support of the plaintiff's and defense bars, is to provide parties with an option of a faster and simpler jury trial. (*Code of Civil Procedure* § 630.01. et seq.) When feasible, the trial is to be concluded within one day; however, juries are allowed to deliberate as long as needed.

So far, the process has not been used in the Ventura Superior Court, but other counties have used expedited trials for minor personal injury automobile accident cases. Our Civil Law Judges support the process to allow for quicker and more efficient resolutions of simple civil matters.

To get started, all parties must agree and enter into a proposed consent order. The court shall approve the consent order, unless there is a finding of good cause that the case should not have an expedited trial. If any of the parties are self-represented, a minor, incompetent person, or has a conservator, the court must determine if it is appropriate to approve an expedited trial. As part of the consent order the parties must agree to the following:

- Waiver of rights to appeal, directed verdict or post-trial motions, (subject to specific exceptions, CCP § 630.09);
- 2. Each side has up to three (3) hours to present its case; and,
- 3. Each side has three (3) peremptory challenges, unless the court permits an additional challenge in cases with more than two (2) sides;


The following also apply:

- Juries shall be composed of eight (8) jurors with no alternates. The parties may agree to fewer;
- 2. The rules of evidence apply, unless the parties stipulate otherwise; and,
- 3. The verdict is binding, subject to any written high/low agreement or other stipulation.

Use of the expedited procedure should increase the number of jurors that are able to serve. Economic hardship prevents many jurors from serving on civil jury trials due to the length of trials. This procedure will allow juries to participate and quickly return to their jobs.

WELCOME HOME. THANK YOU, NOW HOW CAN I HELP?

"On an average day, eighteen veterans of our nation's armed forces take their own lives. Of this, roughly one-quarter are enrolled with the Department of Veterans Affairs ('VA') healthcare system. Among all veterans enrolled in the VA system, an additional 1,000 attempt suicide each month. Although the VA is obligated to provide veterans mental health services, many veterans with severe depression or post-traumatic stress disorder ('PTSD') are forced to wait weeks for mental health referrals and are given no opportunity to request or demonstrate their need for expedited care. For those who commit suicide in the interim, care does not come soon enough. Like the cavalry of Alfred, Lord Tennyson's 'Charge of the Light Brigade,' these veterans may neither 'make reply' nor 'reason why' to the 'blunder' [of] those responsible for their safety."

This disturbing statement is drawn directly from the opinion of the 9th Circuit Court of Appeals in Veterans for Common Sense and Veterans United for Truth v. Eric K. Shinseki, ____F.3d___ (9th Cir. 2011)



In this landmark ruling, the Ninth Circuit unapologetically lambasted the VA for its continued failure to deliver timely mental health care and disability compensation benefits to veterans. The promise to care for veterans is encompassed in statutorily defined and constitutionally protected services and benefits. The court ruled that the inexcusable delays constitute a deprivation of property and an unjustified violation of a veteran's right to due process.

The majority opinion ordered the lower court to oversee a complete overhaul of the VA health care benefits system and admonished Congress and the Executive Branch for having failed to respond appropriately.

The Greatest Lesson I Learned

Back in the Dark Ages, when I went to UCLA, there was one class that all of us so-called "student leaders" wanted and needed to take. It was an upper division Poli Sci class taught by Dr. Charles Titus and was simply called "Politics." It had nothing to do with Democrats and Republicans but with how to motivate people and to think and be a leader. It was a very competitive class. Each week Dr. Titus announced the class ranking of all of the students and we all tried desperately to be in the "first quartile" and be able to sit in the first two rows of the classroom.

Dr. Titus started each class with a quiz. After reading Machiavelli or John Stuart Mill or Cicero, we never knew what to expect. Once when we came into class there was a hand of bridge on the blackboard. The quiz – "What is your bid?" Dr. Titus' point was if you are going to be a leader, play leaders' games. Another time, Professor Titus gave us a list of dinner guests (the Governor and his wife; the Chief Justice of the State, etc.). Our job was to seat them around the table in the proper protocol. Yes, there is a protocol – you are seated in descending importance from the host and do not put the spouses next to each other, but across the table from each other. I didn't know that either.

One day we were given a quiz. The obvious (and only) answer was "A." Dr. Titus, the good professor, ended the quiz by announcing that the answer was "B," but he had no time to discuss it as he was running a bit late. There were a lot of moans and groans, but we went on.

The next time the class met, Dr. Titus announced that the following four students got the quiz right and he wanted them to come to the front row and be seated. Everyone was confused. How could they have answered "B"?

Dr. Titus told us that the golden four had indeed answered "A" just like everyone else. But during the week, they came to his office and asked how could that possibly be correct? The real quiz, he said, was what would we do with information that we absolutely knew was wrong. In our life as leaders we would be given so much information that is just wrong and if we merely accept it, he didn't want us in his class...certainly not in the front two rows.

I was not one of the four, but it was the greatest lesson I learned at my alma mater. I've never forgotten it. Talk about a great teacher....

It also demonstrates to young adults our respect for the legal profession and the American system of justice.

In recent years, more local high schools have become involved in Mock Trial, and others have asked to form teams in 2011-12. Veterans and their families struggle to cope with health conditions and problems without assistance as thousands of disability claims languish in the VA bureaucracy and a clogged court. The backlog of appeals keeping veterans from benefits is staggering. With unplanned-for physical and psychological wounds, veterans wait six months on average to receive disability benefits and as long as four years for appeals to be heard after benefits have been denied. Service providers at the local vet center in Downtown Ventura told me that the tremendous log jam includes veterans as far back as World War II. The Army Times reports that pending claims for compensation stand at approximately 756,000 and growing. ["Zoroya, Critics Rip VA for Increased Claims Backlog," April 6, 2011 (www.armytimes.com/news/)]

In a response to the unprecedented need for veteran advocates, the California State Bar collaborated with Practising Law Institute and Swords to Plowshares (a nonprofit organization assisting veterans since 1974), to offer no-cost MCLE training for lawyers to assist veterans appealing for benefits. The free training remains available on the PLI website at *http://www.pli.edu*.

Although you do not have to be an attorney to become a veterans advocate, you must become accredited by the Department of Veterans Affairs. As an attorney veterans advocate you are required to complete three hours of qualifying CLE and file an application for accreditation with the Department of Veterans Affairs (available at http://www.va.gov/OGC/docs/Accred/ VA21a.pdf). Applications are processed in approximately six weeks. Of course, there are thousands of cases up on appeal, but only one case a year could make a difference to one veteran and their family.



NEW PATIENT PRIVACY RULES MEAN NEW CONCERNS FOR ATTORNEYS

On May 31, the Office of Civil Rights proposed new HIPAA Privacy rules that will make it easier for patients to investigate persons who viewed their medical records within the last *three years*.

The Office of Civil Rights derives authority for its new rules from a portion of the HITECH Act. HITECH aims to digitize all "protected health information" by Jan. 1, 2014.

Proposed rules for *access reports* will require "covered entities" and "business associates" to identify specific persons who accessed their protected health information. The *accounting of disclosures* rules requires covered entities to provide detailed information (a "full accounting") for certain disclosures that are most likely to impact the individual.

Penalties

The proposed rule increases penalties and enforcement for HIPAA violations. The Office of Civil Rights is directed to conduct periodic audits of covered entities and business associates to evaluate compliance. To enforce the rules, the OCR is increasing the number of investigators in ten regional offices. State attorneys general will be authorized to file civil actions to recover statutory damages on behalf of state residents.

Parties cannot avoid penalties by claiming they had no knowledge of the violation. Under the proposed rule, the lowest penalty range, where the violator "did not know (and by exercising reasonable diligence would not have known)" is \$100 to \$50,000 in a calendar year. Higher levels of culpability include "reasonable cause" to know and "willful neglect" (characterized by intentional failure or reckless indifference to the need to comply) and could result in penalties of up to \$1.5 million per calendar year, increased from the \$25,000 limit for identical violations regulated under previous rules.

Satisfactory Assurances

HIPAA rules apply directly to covered entities and broadly to business associates. Federal jurisdiction touches business associates because HIPAA requires covered entities to obtain "satisfactory assurance" (in writing) that each business associate agrees to safeguard the protected health information from misuse. The Office of Civil Rights's proposed rules will expand business associates' obligations to help ecovered entities comply with accounting/reporting obligations. (The Department of Health and Human Services publishes templates for *BA Contracts* on the web.)

Definitions of business associate activities are listed in 45 CFR §160.103. Attorney services are not specifically listed; however any law firm that accessed personal health information electronically within the last *three years* could be included in the covered entities' audit trail.

California Law

Lawyers often get copies of medical records by submitting signed authorizations (Civ. Code, §56.11) to clients' health care providers. But what happens if a doctor responds by emailing a copy of the client's protected health information? Does the attorney automatically become a business associate if medical records are disclosed electronically?

The answer is no. Once a client waives confidentiality for disclosing medical records, then California law (not HIPAA) establishes the attorney's standard of care. The lawyer has discretion to "use" client medical records to prosecute or defend lawsuits. Discovery statutes also protect "consumers" when medical records are subpoenaed. Conversely, if the attorney is retained to examine protected health information belonging to non-clients, then a business associate contract should be executed. For example: A medical malpractice defense lawyer might ask a physician to provide copies of the complainant's protected health information so the lawyer can evaluate the merits of a pending or threatened lawsuit.

If the business associate's examination of protected health information occurs within the covered entity's business activity, HIPAA law considers it a "use" of protected health information. If business associate access goes beyond the scope of the Business Associates Contract, such access becomes a "disclosure."

Avoid Disclosing Unsecured Personal Health Information

The easiest way for lawyers to avoid HIPAA problems is to identify the source of electronic health records. If the electronic health record was *not* obtained by legal process (subpoena or client authorization) the record might be protected health information subject to HIPAA rules. The lawyer should store such files in an encrypted format pending further instructions.

Protected health information is presumed "secure" whenever it is encrypted (45 CFR § 164.304). Complying with new HIPAA privacy rules is not tricky if the lawyer avoids disclosing unsecured PHI. This is not as difficult as it sounds.

PHI Encryption

Encryption software is inexpensive to purchase. Shareware such as *TrueCrypt* (free) can be downloaded and installed within minutes. The user may partition an encrypted area on the computer's hard drive, or encrypt a flash drive plugged into the USB port. Once the encrypted folder is mounted, the user selects a password (at least 20 characters) and transfers all of the protected health information files into the encrypted folder. After the folder is dismounted (by closing the folder or removing the flash drive), the protected health information cannot by accessed unless the user re-enters the password. If the user forgets the password, the data will be encrypted forever (essentially lost).

If a laptop or flash drive is lost and someone else tries to access encrypted files, the protected health information will be "secure" because the finder does not know the password. When encrypted protected health information is delivered to a trusted person, the attorney should also convey a secret code or pass phrase to open the encrypted files. An inside joke of 20 to 60 characters would be a viable encryption key that would be easy to convey verbally.

Civil Enforcement

Unencrypted protected health information leads to trouble. For example, Connecticut's attorney general filed a case against Health Net after an employee lost a portable computer disk with unsecured protected health information and financial data belonging to 446,000 individuals.

"Protected private medical records and financial information on almost a half million Health Net enrollees in Connecticut were exposed for at least six months – most likely by thieves – before Health Net notified appropriate authorities and consumers," Richard Blumenthal, the Connecticut Attorney General, said.

Health Net settled the case by agreeing to provide credit monitoring and identity theft insurance to affected individuals. The state of Connecticut also recovered \$250,000 statutory damages.

Criminal Enforcement

A cardiothoracic surgeon from China was one of the first HIPAA violators to be sent to federal prison just for snooping. He was employed as a researcher at UCLA but was terminated for reasons unrelated to HIPAA. On the evening of his dismissal and during the following three weeks, he remotely accessed the electronic medical records of his supervisors and co-workers as well as those of high-profile patients, including Tom Hanks, Drew Barrymore and Arnold Schwarzenegger. He was only able to commit these violations (a total of 323, according to the FBI) because access to these records was not adequately controlled.

UCLA subsequently expanded its training program and increased its IT auditing capabilities and doubled the number of auditors. Since then, no celebrity protected health information has been snooped or disclosed from UCLA.

Comment Period Ends August 1

The Office of Civil Rights has made a series of judgments that attempts to balance individual rights with burdens imposed on covered entities and business associates.

Whatever your practice, whenever you provide legal services involving the disclosure of protected health information you are subject to HIPAA regulations and the changes discussed above. Therefore, you may find it useful to review the Office of Civil Right's' proposed rules. The opportunity for public comment ends Aug. 1.




