

## **SIJS Cases** in local courts

### Limited Scope Representation

Custody/Guardianship order with SIJS findings



Non-Adversarial

Only one parent is involved (at most); No criminal case



## SIJS Findings

can pave the way for immigrant youth to secure long-term lawful status in the United States.





## BEST INTEREST OF THE CHILD






### Settled custody/guardianship

### May be able to remain permanently in the USA

## SIJS > DACA for many children



## WHO CAN BENEFIT from SIJS







Under age 21 and unmarried

Present in the US

### At risk of deportation

not US citizens or LPRs (green card holders) in their own right, may or may not already be on ICE's radar

### Want to remain in the US

even if their parent/s cannot



### Victims of abuse, neglect, or abandonment

by one/both parent(s) in the US or elsewhere. Neglect or

Abandonment may be involuntary



a parent's death, deportation, incarceration, or other incapacity

### Better off remaining

in the US than returning to their country of nationality or previous habitual residence





What was care in home country-nutrition?

Ensure inclusion of all facts in the Order, to ensure USCIS has strongest possible record upon which to make grant of SIJS



# **SIJS** the good and the bad

Permission to remain in the USA indefinitely

Does not include permission to work or travel until the person is applying for a green card

Pathway to a green card & citizenship



Someone who gets SIJS can never sponsor either parent for an immigration benefit

applies only to the individual SIJS grantee any siblings could still sponsor the parents


