Kentucky Court of Appeals

J.T. v. S.B., No. 2008-CA-002149

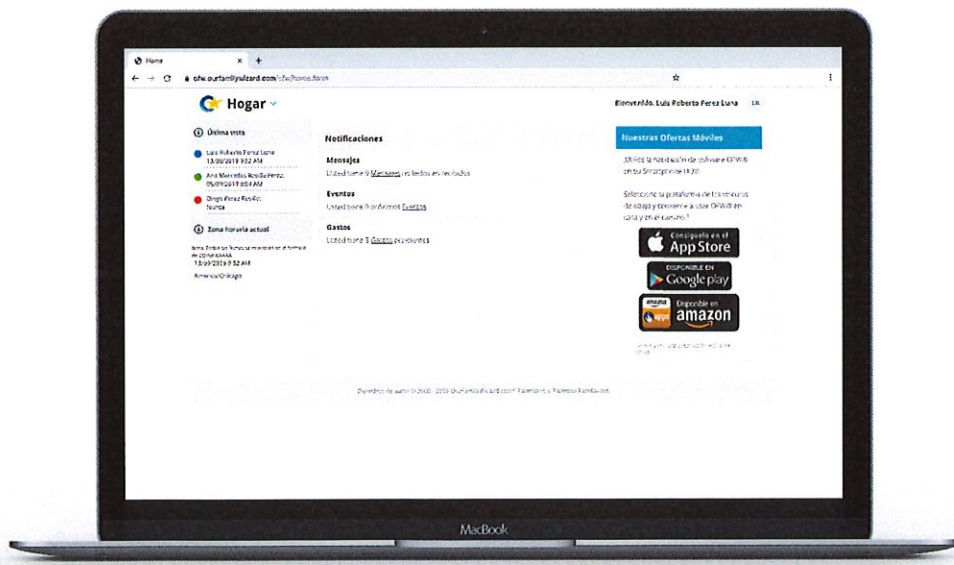


