Justice Jenkins was confirmed as an Associate Justice of the California Supreme Court on November 10, 2020, following his appointment by Governor Gavin Newsom. Previously, he served as Senior Judicial Appointments Advisor to Governor Newsom. Justice Jenkins' judicial experience includes service as a federal district judge for the Northern District of California. After graduating from Santa Clara University and before entering the University of San Francisco (USF) School of Law, Justice Jenkins was briefly employed as a player by the NFL's Seattle Seahawks. He obtained his law degree from USF in May 1980, when he received the Judge Harold J. Haley Award for "exceptional distinction in scholarship, character, and activities." After graduation, Justice Jenkins worked as a prosecutor for the Alameda County District Attorney's Office.
